(1) "17th July 2018 Good morning I refer to your letter dated 10/0718 regarding the above event that was held in 2017 and your information that a similar event will be held between 17-19 August 2018. I am aware that after last years event a number of complaints were made to the local Policing team about noise and nuisance at this event.

The process for applying for temporary event licence authority (TEN) is that the applicant has to send copies of the application to the council Licensing Authority, Environmental Health (EHO) and the Police.

The council licensing authority are the body responsible for all licensing applications.

Where a TEN has been submitted, only the Police or EHO can make representations - which can include objecting to an event.

I can confirm that as at this date, no application has been received by the Police with regards to this event - however I can say that there is still sufficient time for an application to be made.

What I can confirm that the Police will be considering their options if an application is made.

However Police objections will normally be based on crime and disorder concerns and not the nuisance issues you are reporting. However please be assured that the Police will seriously consider the option to object to the event.

Throughout the summer period the council have a 'noise team' working weekends (2100hrs to 0200hrs). They can be contacted if a significant issue occurs through the councils out of hours number - 01432 26176. Please feel free to share this information to those who you feel require it. News from the Nick An open day is being held at the fire station, where we are based, on Saturday 14th July from 11am – 4.30pm, organised by our colleagues from Hereford and Worcester Fire and Rescue. Pete and Roger will be there for the day, so come along and say hello.

Crime Trends 1^{st} – 30th June 2018 You will be pleased to hear that we have had no reports of thefts or burglaries in the Golden Valley this month, this is fantastic news. There have been plenty of other incidents keeping us busy however, from missing persons, road traffic collisions and neighbour disputes/domestic disputes to name but a few.

There was a suspicious incident in **Wormbridge** on Wednesday 27th June where the tail of a horse in a roadside field had half its tail cut off, and left draped over the field gate <u>Incident ref 172-s-270618</u>

If you have any information regarding any crime you can contact police on 101, in an emergency please dial 999. Please be aware that any information provided within this letter is to inform you of incidents of note and to request possible assistance. We do not want to worry you in anyway.

Any incidents stated are infrequent and spread about a wide area, and are over a whole month.

Herefordshire is a safe place to live!

Results and local arrests Residents of Eaton Bishop will remember seeing large amounts of rubbish dumped in four places around the village back in January – here is a photo of one of the sites





After extensive enquiries by Craig Sandman, our colleague at Herefordshire Council, the rubbish was traced to a household in **Kingstone**.

A 34 year old male was questioned and although he admitted the rubbish came from his household, he claimed he had paid someone to take it to the tip. He refused to give further details and was fined £300 under s34 of the Environmental Protection Act for duty of care offences. This is because it was his responsibility to ensure that the person paid to dispose of the rubbish did so correctly.

A 59 year old male from **Dorstone** was issued with a £150 fixed penalty for depositing litter in Archenfield, having been seen throwing a bag of rubbish from his car into a field – this had been happening on a regular basis in the same place, which he admitted to.

A 23 year old male from **Kingstone** was also issued with a fixed penalty for littering in Kingstone; he was caught on CCTV throwing items from his car.

Two adult males and an adult female were arrested in **Peterchurch** on suspicion of assault; they are on police conditional bail.

Cold callers – 'scrap dealers' We have had several reports of persons calling at properties asking for scrap recently – we would be grateful if you could take down registration numbers and pass them to us if they call on you. You can contact us on our mobiles, on 101 or by e-mail, and we can pass details to our colleagues at Trading Standards.

Scam news Another scam report sent to us by one of our readers –

Just when I thought it was safe to pick up the phone! Today's scammer called at 13:11 from 01254 785876 Pre-recorded message, female American accent stating that the call was from my internet provider (not specifically which one)

My router was being switched off within 24 hours as my IP address had been compromised. A number of options then given to select a resolution to the matter......

This one is going to alarm a number of experienced individuals let alone the more vulnerable out there.

Needless to say – hang up and block the number if possible.
