I have attached the notification of public meetings of the Herefordshire Council that you might like to draw to the attention of Parish Councillors and indeed the public generally. Follows a few comments:-

As councillors will have noted since we last met there has been a long session of road works along the A465 all part of the repairs from monies received by the Herefordshire Council from central government that have to be used by March 2018. I am informed that the method of repair is designed to be of a standard that will require less maintenance over the next ten to twenty years Planning applications are currently running at least 20% above the usual level and parishes and clerks may well notice the knock on effect in terms of notifications reaching them.

I am in contact with the management of the saw mills after receiving objections from residents who are affected by the noise and the working hours.

The Parish Council were extremely concerned about the lack of notification, Licensing Information, involvement with the Fire Brigade, the Police, First Aid and Traffic Assessments.

#### 8.0 Spitehouse Rise Pontrilas - Street Lighting

To consider correspondence received from Collins Design & Build

"8<sup>th</sup> November 2017 Dear Malcolm We are in the process of finalising the design and associated costs to do the adoptable foul and storm drainage, roads and the pavement. The cost are proving far more than we had expected mostly because of the difficulties with the pavement, which has to be taken right back into the hedge and therefore requires complex retaining walls to hold up the hedge and the bank behind. The retaining walls alone to enable the construction of the pavement will cost  $\pm 34,742 + VAT$ + plus the council fees to approve the design and to inspect it etc (approx another  $\pm 8000$ ). We also need to move a high pressure water main and BT fibre broadband that are presently in the highway verge where the pavement is going at considerable additional cost. On top of this is the construction of the pavement and sign moving of course.

I am writing again to respectfully ask that the PC drop the demand for the streetlighting of the footpath because it is another unforeseen cost that is making the development increasingly unaffordable. The Council highways and planning departments were not anticipating a need for the footpath to be illuminated and they are entirely comfortable that an unlit footpath still provides a safe link between the site and village. The cost of the streetlights are also considerable as we have to pay Baflour Beatty to design and install them, we also have to pay Western Power to bring a new electricity supply to them which necessitates digging up the road as the nearest supply is at Court Farm on the opposite side of the junction road.

I am sure it is tempting to say we should have thought of this beforehand and costed it at the budget stage but in fact that is just not possible until you get into the construction phase of design and this entire series of events has been completed.

The whole design also has to be signed off by Welsh Water and the council and they insisted that we get a firm of consulting engineers to design it at a cost of over £20,000. The whole proposal goes to them for a Section 278 and Section 104 legal agreements then we eventually get prices to build it, which is where we are now.

One of the suggestions being the installation of solar powered lighting, to which the Parish Council replied that if a detailed plan could be provided, which was also acceptable to the Highway Authority then consideration would be given to the proposals at that time.

October 2017 Golden Valley Safer Neighbourhood Team (SNT) Newsletter Crime Trends 1st – 30th September 2017



Several buildings at **Madley** primary school were broken into between Friday 1st and Sunday 3rd and an X box was stolen from one (Incident 333-s-070917)

Sometime between Sunday 3rd and Saturday 9th, an unoccupied property in **Madley** was broken into and a search was made of all rooms, but it is unclear if anything was stolen (Incident 504-s-090917)

Overnight on Tuesday 5th/ Wednesday 6th a quantity of lead and some extension leads were stolen from a property undergoing renovation in **Longtown** (Incident 370-s-060917)

On Wednesday 6th, a charity minibus parked in the car park at The Co-op in **Cusop** had a window smashed (Incident 770-s-060917)

Overnight on Saturday 9th/ Sunday 10th, a cement mixer and 14m cable were stolen from the grounds of a property undergoing building works in **Clifford**. A locked stable block was also broken into at the same location, but nothing was taken (Incidents 204-s-110917 & 235-s-110917)

In the early hours of Sunday 10th, buildings on a farm in **Clifford** were broken into and a Stihl petrol chainsaw and a Stihl leaf blower were stolen (Incident 509-s-100917)

Overnight on Sunday 10th / Monday 11th a Karcher pressure washer, a Stihl chainsaw and a roll of electrical cable were stolen from a farm in **Dorstone** (Incident 282-s-110917)

Two youths were disturbed by neighbours breaking into a garage in Oak Crescent **Clehonger** (Incident ref 784-s-120917)

Overnight on Thursday 14th / Friday 15th a Honda quad bike and a Honda generator were stolen from locked sheds on a farm in **Clifford** (Incident 94-s-150917)

A quantity of lead was stolen from part of the church roof in **Madley** sometime overnight on Friday 15th / Saturday 16th (Incident 286-s-160917)

A Peugeot Partner van parked outside **Belmont** Abbey was broken into between 9.30 – 11.00 am on Sunday 17th, but nothing appears to have been stolen (Incident 334-s-170917)

Overnight on Thursday 21st / Friday 22nd, two roadside garages in **Clodock** were broken into, and a Nilfisk pressure washer was stolen (Incident 110-s-220917)

Also overnight on 21st/22nd a large outbuilding in a remote part of **Lower Maescoed** was broken into, and several tools were taken (Incident 302-s-220917)

The same building was broken into again between Monday 25th / Thursday 28th, it is not known at this stage what has been taken (incident 530-s-290917)

Damage was caused to the lawn of a property in **Vowchurch** by weed killer being applied in a line across it, this happened sometime during the past three weeks (Incident 22EB/87866F/17)

Overnight on Tuesday 26th / Wednesday 27th, a black Mercedes ML 270 estate was stolen from a farmyard in **Longtown** (incident 272-s-270917)

Sometime in the past month, the tail hair of two horses in a field in **Abbeydore** was cut (incident ref 210-s-240917)

A Kawasaki quad bike was stolen from a shed at a smallholding in **Clehonger** overnight on Friday 29th / Saturday 30th September (incident 217-s-300917)

If you have any information regarding any of the above crimes you can contact police on 101, in an emergency please dial 999. Please be aware that any information provided within this letter is to inform you of incidents of note and to request possible assistance. We do not want to worry you in anyway.

Any incidents stated are infrequent and spread about a wide area, and are over a whole month. Herefordshire is a safe place to live!

**Good News** Back in April 2016, PC Tom Milton assisted our colleagues at Trading Standards by arresting Martin Evans, trading as Eco Solutions from Brynhonddu Lodge, Pandy, Abergavenny for fraud by false representation. He was offering to carry out work and misleading several vulnerable people, who had been 'conned' out of several thousands of pounds for work not done or done to the required standard, including a resident in Ewyas Harold.

He was found guilty of 8 out of 9 counts (including 6 frauds of gross overcharging against six elderly victims) at Worcester Crown Court on 1st September after a two week trial. He is due to be sentenced on 2nd October and the judge has told him to expect a custodial sentence.

We will update you with details of his sentence in the next newsletter.

A 23 year old male from Kingstone, Paul Simcox, pleaded guilty at Hereford Magistrates court on 4<sup>th</sup> August for failing to transfer controlled waste to an authorised person and transporting waste without a Waste Carriers Licence. Simcox responded to an online advert requesting the removal of household rubbish from a house in Gloucester.



He took the waste and then dumped it in two locations, on the Holmer Trading Estate and on the Lulham to Preston on Wye Road. Simcox was fined £1,050 with costs of £750, a victim surcharge of £40 and compensation of £75, totalling £1,925. A robust message to all fly tippers!

And finally, on a lighter note! The Highways Agency found over 200 dead crows on the M4 near Bridgend recently, and there was concern that they may have died from Avian Flu.

An avian pathologist examined the remains of all the crows, and, to everyone's relief, confirmed the problem was NOT Avian Flu. The cause of death appeared to be from impacts with vehicles.

However, during analysis it was noted that varying colours of paints appeared on the bird's beaks and claws. By analysing these paint residues it was found that 98% of the crows had been killed by impact with lorries, while only 2% were killed by cars.

The Highways Agency then hired an Ornithological Behaviourist to determine if there was a cause for the disproportionate percentages of truck kills versus car kills. The behaviourist quickly concluded that when crows eat road kill, they always have a look-out crow to warn of danger.

They discovered that while all the lookout crows could shout "Cah", not a single one could shout "Lorry" **How to Contact Us 101** to talk to your local SNT or report a crime
