# 5.0 <u>Reports</u>

**5.1** Ward Councillor Mr Graham Powell gave a verbal résumé of the following:-

"Kentchurch GPC Ward Member Report - January 2017

**2017/18 Budget Update** The provisional financial settlement announced on 15<sup>th</sup> December 2016 confirmed the following:

Confirmation of the 2% council tax referendum principle

Confirmation of an additional 2% adult social care precept and ability to raise the adult social care precept to 3% in 2017-18 and 2018-19 but no more than 6% over the next three years Reduction in the number of payment years for the new homes bonus from 6 years to 5 years in 2017/18 and to 4 years in 2018/19. Bonus will also only be paid above a 0.4% housing growth baseline.

Savings from the new homes bonus to be allocated to local authorities through an adult social care support grant

The net result of these changes is:

A reduction in the New Homes Bonus (£1,065K)

New Adult Social Care Support Grant£885K

Cabinet made their recommendation to Council on Thursday 19th January:

(a) the council tax base of 67,937.91 band D equivalents;

(b) an increase in council tax in 2017/18 of 1.9%;

(c) an additional precept in respect of adult social care costs of 2.0% applied to council tax in 2017/18.

The impact of the above recommendations will result in a total council tax increase of 3.9%; increasing the band D charge from £1,324.83 to £1,376.50 for Herefordshire Council in 2017/18.

Council will discuss and agree the budget in February and the Council Tax (including precepts) in March 2017.

**Hereford Car Park Tariffs** The off street car park tariffs in Hereford have been reviewed and a new schedule of payments will come into effect from February 2017.

Maylords Orchard will change from a pay on exit facility to a pay and display car park. This is more cost effective and will be easier for disabled users who currently have to use the

Shopmobility office for ticket validation. Most charges remain the same with some reductions. **Hereford Library** Hereford Library will reopen on Tuesday 31 January 2017 following the

phase one completion of building work at Broad Street. Further work on the development of the building will follow.

Customers can look forward to a refreshed ground floor interior, including new meeting rooms and accessible public toilets. The county library will also welcome WISH (Wellbeing Information and Signposting for Herefordshire) which will operate from the main library when it reopens.

The temporary library at Hereford Town Hall will close on Saturday 21 January to enable the move back to Broad Street. Customers can use the Town Hall drop box to return library items during the period of closure.

# Three Elms housing development planning application - Hereford

Welsh Water is proud of its record in supporting investment in the local area and also its efforts to support sustainable growth for the local economy. As a statutory consultee in the planning process, we always carefully consider every planning application with a view to supporting local economic development. This is done alongside our ongoing commitment to provide the most essential of public services through maintaining and protecting local water and wastewater networks.

Our process in considering planning applications always includes the potential impact on our infrastructure in the local area – including the local environment, the service we provide for customers or any possible increased risk to homes and businesses in the area.

We will always do everything we can to support sustainable growth. Over the last two years, we have invested nearly **£5 million** in our services in Hereford to help improve the resilience of the water and wastewater networks. We plan to invest more than **£21 million** over the next 2 years which will enable us to help support developments such as the Three Elms project as well as future growth planned for the area.

We also work with stakeholders, such as local businesses, to address any concerns they may have around the potential impact of any proposed development on the services we currently provide. To that end, we will liaise with Heineken, so that we can understand their requirements in the area, and if requested, help them with their water supplies.

"Dear Ms. Jenman,

Kentchurch Parish Council as an adjoining Parish considered this application at its meeting held on the 25<sup>th</sup> January 2017.

While considerable concern was once again raised about what the Parish Council consider is the inadequacy and hence dangerous HGV entrance / exit to the site and the fact that although part of a previously approved condition to provide a lorry park for its own vehicles and clearly shown on the currently provided plan has never come to fruition, which means that all the local lay-bys are full of HGV's overnighting which in its self is prohibited.

Also shown on the plan supplied is the Emergency Vehicle Access which is in need of considerable improvement.

While the above items are clearly not part of the current application surely these issues should be addressed prior to further development.

However, the Parish Council <u>resolved unanimously to support</u> this current application on the basis of an improved working environment for the employees, containment of noise and the increase in production capacity for the company.

# Golden Valley Safer Neighbourhood Team (SNT) Briefing <u>17th December 2016 - 3rd January 2017</u>

A very Happy New Year to you all! We have had just two property crimes reported to us since the last briefing on 17th December, lets hope the low crime rate continues into the New Year.

<u>Crime Trends Dorstone</u> An isolated set of farm buildings in Middlewood were broken into on two nights running on 21st/22nd and 22nd/23rd December. On the first occasion nothing was taken, but the following night several batteries were stolen <u>Incident refs 179-s-221216 & 244-s-231216</u>.

<u>Kingstone</u> The childcare unit at Kingstone High School was broken into sometime over the Christmas break; it was closed on Friday 23rd December and when staff returned on Wednesday 28th December they discovered the door had been forced open, and although damage had been caused to several cupboards inside, nothing appeared to have been taken. It is believed the suspects were looking for cash, which is never left at the premises Incident ref 162-s-281216

There have been minor shoplifting offences reported to us from Madley and Clehonger village stores, but the suspects are known and will be dealt with in due course.



<u>Scams</u> We have received an email from another of our readers about some telephone calls they received which they wanted you to be made aware of..

"We received several calls (last week) out of normal banking hours allegedly from "Nationwide" credit card team asking for either myself or by husband by name.

Due to earlier briefings from GVSNT, (and the fact I don't have a NW credit card) we were suspicious and refused to take the calls.

1471 revealed the number to be either 02077230740 or 02077230741

Redialling – the number was unobtainable.

The last call came through to myself asking for my husband.

I challenged the caller who was very convincing and offered to give me a "safe" Free phone number I could call back on.

I declined.

The caller was unable to email the details of his call or SMS text to my husband's mobile (something Nationwide would have done)

I spoke with the Nationwide Credit Card team – neither of the two telephone numbers were recognised as valid & they had no record of needing to contact my husband.

However, Nationwide can do nothing to investigate these calls until a fraud has been committed and did not take any details or pass me onto another department.

These callers are very sophisticated & very convincing!

I would advise anyone to terminate the call politely and visit their local branch with details rather than giving any details out on the phone.

Sadly, in an age where most banks are closing their branches this may not always be possible.

Hoping this helps keep someone safe!"

Another reader wanted to pass on this advice .....

"Could I make a suggestion for a future issue relating to not downloading or opening suspicious messages with attachments.

Another crucial aspect is that people keep their computers up-to-date with latest versions of software be it operating systems such as Windows and antivirus software.

There are also issues that some people may still be using Windows XP and think that is all right. Well, not exactly recommended as it is no longer supported and those intent on hacking know that so it is an open goal.

Whether users want to rely upon free antivirus software, that is their choice and I'm not saying anything against it but it just might not offer the levels of security of some paid for products."

Golden Valley Safer Neighbourhood Team (SNT) Briefing <u>3rd - 12th January 2017</u>

<u>Crime Trends</u> <u>Cusop</u> A business unit on the Glan Wye business park was broken into between 3pm on Saturday 7th and 3.30pm on Sunday 8th January. A padlock was forced off the entrance door to the unit and once inside the door to the office was forced and a cordless screwdriver and sander were stolen Incident ref 488-s-080117

<u>Kingstone</u> The portacabin used by the Army Cadets at the High School was broken into sometime between Thursday 8th December 2016 and Thursday 5th January 2017, but it is believed it was probably broken into at the same time as the childcare unit that was reported in the last briefing. A considerable amount of damage was caused breaking into the building, and to internal fixtures during the incident. A quantity of s weets and a small amount of cash in a cash tin were stolen <u>Incident ref 605-s-050117</u>



Madley A large open structure used to store 1000 tons of straw near The Comet Inn was set alight around 11pm on Wednesday 4th January, causing a massive blaze that kept the Fire Service at the scene for 24 hours. The estimated cost of the damage is in the region of £55,000 and an investigation to trace the perpetrators is underway. <u>Good News</u> As a result of enquiries, a property in Kingstone was searched and a large quantity of stolen goods were recovered, most of which have been returned to their owners -

The owners of a shed that had been broken into in Stoney Street, Madley last November has had eight of the nine power tools that had been taken returned to them;

Madley Environmental Study Centre has had a generator returned to them that had been stolen in October; The owners of a house that had been burgled in Kingstone in October has had several but not all of the stolen items returned to them.

There are still a few outstanding items of property to be returned to their rightful owners and enquiries are ongoing to trace them.

A 54 year old male from the address where the property was found has been arrested and is on police bail whilst enquiries are ongoing.

<u>Scams</u> Another couple of telephone scams have been brought to our attention by two of our readers..... I had a 'phone call taken by my answerphone which asked me to call my bank and gave a 'phone number to do so.

I used this 'phone number and found I was talking to the M&S bank. I was asked for the number on my M&S credit card which I did not give.

I then 'phoned my bank to ask about it but they could not do anything.

As I was suspicious I simply removed the message from my answerphone and left it at that.

The voice was a woman's and sounded very creditable but I found it all very odd.

Good Morning

There is another phone scam in the area. Repeated calls from 01671 591444, if answered first calls went dead with no speech. Final call was a male with a very strong Asian/Indian accent who said he was calling from my internet provider warning of an Internet security breach in this area and wanting info regarding my Router security. Apparently my computer is reporting attempted hacking from Mexico and China. When I challenged him he offered his name as Richard (Jones?) and said he could give me a direct number for BT technical security, which I could call from my mobile whilst he stayed on my landline. They would he able to confirm he was a genuine caller from PT. I declined his offer and hung up. PT confirmed it to he

be able to confirm he was a genuine caller from BT. I declined his offer and hung up. BT confirmed it to be a scam and I have not had any more calls since.
