5.1 Ward Councillor Mr Peter Jinman reported on the following:-

Flooding issues through Pontrilas, a meeting had taken place with Peter, Balfour Beatty Living Places, Herefordshire Council, Welsh Water and the Environment Agency. a survey has been undertaken of the river and there should be a report completed by November/December 2020 and hopefully this will assist in preventing flooding in the future.

Flooding at The Conifers apparently the "bund" is too low and the culvert/ditch requires cleaning out. Mr Nigel Ward has accepted responsibility for part of the Station Approach Road and has agreed to proceed with some repairs.

Meeting with Committee Chairman reference Covid 19 Regulations, Herefordshire has the lowest level in the West Midlands, even though the schools are back but it is still a major concern

Herefordshire Council Covid 19 and Flood finances have a several million shortfall

Fownhope flooding issues costs were enormous

Most of Herefordshire Council employees are still working from home

There is a backlog of Planning Application to be processed

Motorcross issues – discussion are on-going

Broadband/educational poverty is still a problem there will be a Cabinet update soon

The Parkway Railway Station is still proceeding. The relevant Government Ministers are now all talking to each other about the railway which seems positive. There had been some confusion as to the understanding as to the approach being taken to the station by officials within the Council Departments but after emails etc. matters had been cleared up and an assurance received that the project is being fully backed by both the responsible Cabinet Member and Officials.

Councillor Mr K John Chance Chairman thanked Peter for all his help during the flooding both in Pontrilas and Ewyas Harold areas.

*A meeting to be arranged between Herefordshire Council, Farmers/Landowners etc maybe in November 2020.

5.2 Lengthsman Report Parish Council to agree future works

Parish Council Lengthsman/Contractor Mr Dave Roden not present and no report available £6,000.00 extra monies ring-fenced for Lengthsman works and £3,000.00 for ditches, headwalls grips etc.

Agreed for Dave Roden to cut some grips to allow water to drain into the field up The Chemical *Areas at Parkside Kentchurch and Spitehouse Road Pontrilas, Riparian Ownership requires to be established
