"Hi Malcolm, I have worked out the costs to install new noticeboard at Kentchurch and to fully refurbish the noticeboard in Pontrilas comes to £1,320.48 including VAT

The work that has been carried out for Kentchurch Parish Council up to 1st January 2023 comes to £936.00 including VAT The work carried out was cutting back vegetation and hedges and spraying in Pontrilas Village, Cutting round signs in parish and visibility splays, Clearing footpath to Ewyas Harold and spraying, Cleaning grips and gulleys and inspections. Many Thanks Dave Roden"
