Reference Prow issues

Good afternoon Ceri.

We have a number of PRoW issues which require attention,

- 1) The bridge at the South East end of the KZ13 (see jpg 002 & 004). Are the rails to assist walkers or prevent walkers from using the bridge also a number of horizontal rails are rotten and require replacing. The whole bridge requires an inspection as you may be able to see from the attached appears to be sagging in the middle. Can you arrange for a safety inspection and if considered safe for our Lengthsman to repair are you able to provide relevant specifications for the materials.
- 2) At the north end of the KZ13 there is a kissing gate which can probably be repaired (see jpg 007) however the wooden finger post has rotted off (see 007 & 005) can you please advise specification for replacement of post and finger.
- 3) Can you advise the process of obtaining grant funding for this work to be carried out? Malcolm Walker Clerk to Kentchurch Parish Council

Good afternoon,

There are a number of issues within the Kentchurch Parish which our Footpaths Officer has reported.

- 1) KZ 22 which is a continuous serious of steps down from the C1234 onto Station Approach towards the C1233. Volunteers have cleared detritus etc from the steps however the wooden hand rail which did run from top of the flight to the bottom is rotten and in danger of collapse if it was to be grabbed should anyone stumble on the steps. Replacement required.
- 2) KZ 10 Bannutree Lane end the finger post is completely out of the ground and leaning on the wall, post is fine just needs digging in again. (SEE Picture KZ 10)
- 3) KZ 17 The footpath should be at bottom corner of the field where there must have been a foot bridge once, the farmer has now planted that field and it is the one that was an issue last year, nothing been done as far as I can see, the corner is still fenced off but there is a sign on field gate further along PRoW needs clearing and a new footbridge is required. (SEE Picture KZ 17)
- 4) KZ 7 Kentchurch end is very muddy probably worse when wet and warning signs on extra grid attached to the stile plus the bottom post for the handrail is very wobbly possibly rotten (SEE Picture KZ 7)
- 5) KZ 4 The metal footpaths sign has been removed although the stile is clear and easy to see. Can you please arrange for these issues to receive attention Thank you Malcolm Walker Clerk to Kentchurch Parish Council
